# THE BULL CITY HOT SHEET

## About the Bull City Hot Sheet

The Herald-Sun, in conjunction with the Durham Police Department and the Durham Sheriff's Office, is featuring each week information on people who are wanted on outstanding warrants.

Listed are the individuals' names, date of birth and charges they are facing.

The Police Department launched the Bull City Hot Sheet in February, and The Herald-Sun is running information on suspects each Monday from warrants issued in the past week.

The Sheriff's Office and the Police Department is providing this only for informational purposes.

Do not try to apprehend suspects. You could put yourself and others at risk. Call Crimestoppers (683-1200), the Warrant Squad (560-4935) or the Durham County Warrant Control Office (560-8883) if you know the whereabouts or have information about any of these people.
